### Matthias Rösch: "Nothing about us, without us – People with disabilities fighting for their rights"

Based on the history and philosophy of the independent living movement of people with disabilities, Matthias will discuss the human rights-orientated approach of the UN Convention on the Rights of Persons with Disabilities (CRPD). How have the consumer organisations of people with disabilities influenced social change and political processes - what milestones and important actions have there been and still are in place? He will also show examples of European and national legislation and the influence of and the impact on people with disabilities. How this has led to more self-determination, empowerment, inclusion and accessibility.

### Humberto insolera: "Empowering Participation: EDF's Political Engagement in EU Accessibility Policy"

Over the last years, the European Union has adopted important legislation to promote accessibility in different fields. From the Audiovisual Media Services Directive to the European Accessibility Act, we have now a comprehensive legal framework in place. In this keynote speech, Humberto Insolera, Executive Member of the European Disability Forum, will provide an assessment of these initiatives from the perspective of the disability community. He will also outline future challenges and propose strategies to address them effectively.

### Vincenzo Falabella:

#### "The role of the associations in the constitutional framework"

The disability world is not a world apart. It is a part of the world. Vincenzo will start from these words to outline a definition of what the term 'disability' means today and to explain how, for eighteen years, i.e. since 2006, there has been a real change, enabled by the approval of the UN Convention on the Rights of Persons with Disabilities, This first UN Convention of the new millennium became Italian Law in 2009. Vincenzo Falabella reports on the work of the FAIP-Ets and will outline the impact that this law has had on politics, regulations, welfare and last but not least on language since.

### Katrin Langensiepen: "Policies for people with disabilities

Katrin Langensiepen will give a practical insight into the work as a Member of the European Parliament and report on the current status of the European Parliament's work in the field of policies for people with disabilities, with a focus on the implementation of the UN CRPD. She will present information on the recent introduction of the EU disability card, the successful establishment of the accessible EU-centres in the member states and the efforts of the UN expert committee to assess the implementation of the UN CRPD.

### Kira Grünberg: "My jump into a new life"

Kira Grünberg talks about how she accepted her new life as it is, what gave her hope and courage to face new challenges and what character traits are necessary to lead a happy life despite a severe stroke of fate. In her talks, she wants to reach people struggling with a similar fate and raise awareness of the topic of inclusion among the general public. After all, inclusion is the only way to foster everyone's talents and potential to achieve more together.

### Frans Penninx: "Dutch examples of political work"

DON, the Dutch SCI Association was founded in 1976 and is the only national stakeholder for people with a SCI. The organisation has three core tasks: providing information, advocacy in healthcare (SCI) policy and laws and peer support. Political work is executed on DON's own initiative and/or in partnership with Dutch umbrella organisations. Frans will give examples of successful petitions and campaigning for e.g. catheter reimbursement and adequate wheelchair provision.

#### Daniela Vozza: "Initiative for an inclusive Switzerland"

In Switzerland, citizens have the right to start initiatives to change the constitution on the communal, state and the federal level. This inclusion initiative calls for a self-determined life for the 1.7 Million people with disabilities in Switzerland

There has been a ban on disability discrimination in our constitution for 23 years. Switzerland has also ratified a law on equality for people with disabilities and the UN Convention on the Rights of Persons with Disabilities. Nevertheless, people with disabilities do not have the same access to human rights as non-disabled people.

### Gunilla Ahren: "An interactive online course for consumers and rehabilitation staff now available in English language"

There's a need to improve theoretical knowledge of spinal cord injuries (SCI) in newly injured persons as well as staff at rehabilitation units, where new staff is being employed continuously. The knowledge needs to be always accessible and easy to understand without much quidance. The Gothenburg Competence Centre for Spinal Cord Injury has produced an online course to meet this need. The online course is now translated in English and free of charge.
